WCL reserves its right to get the pump sets inspected and tested by WCL's representative or third party inspection agency at manufacturer's works before dispatch of the Pumps to ascertain the conformity of the pump set to order specifications, relevant ISS. The pump will be tested as per IS:9137-1978 and IS:5120.
