### 1. General Terms and Conditions-

1.1 This contract is governed by the [General Terms and Conditions](#), conditions stipulated to this Product/Service as provided in the Marketplace.

### 2. Buyer Added Bid Specific Terms and Conditions-

2.1 Scope of supply (Bid price to include all cost components) : Only supply of Goods

2.2 **OPTION CLAUSE:** The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2.3 Buyer Added text based ATC clauses

1. **Performance Bank Guarantee:** - The successful tender has to furnish a Performance Bank Guarantee for satisfactory operation and performance valid for 18 months from the date of supply of Pumps with electrical, equivalent to 10% value of the contract including taxes and duties etc. to the FOR destination price of the equipment on order, covering the warranty period. The Bank Guarantee shall be released after successful completion of the guarantee/warranty period after confirmation from GM(E&M)HOD, WCL(HQ)s. Any shortfall of performance availability, deduction shall be made as per technical specification. No Payment shall be made without submission of Performance Bank Guarantee.. ( Format of PBG is enclosed as Annexure 6 which is to be submitted physically and through SFMS platform)

( This is in addition to the 3% e-PBG ( Security Deposit ) to be submitted on GeM portal)

### 2. INSPECTION :

(a). **PRE-DESPATCH INSPECTION:** WCL reserves its right to get the pump sets inspected and tested by WCL's representative or third party inspection agency at manufacturer's works before dispatch of the Pumps to ascertain the conformity of the pump set to order specifications, relevant ISS, latest (including amendment), statutory regulations (DGMS) and type test certificates. Such inspections shall not, in case of any defect noticed later, entitle the supplier to plead that inspection has been done by the purchaser and absolve them of the obligation. Pre despatch inspection including stage inspection of the ordered material shall be carried out by CMPDIL or it's authorised representatives. The inspection fee @ 1% on FOR destination price plus all applicable taxes and charges shall be paid by you along with inspection call to inspecting authority GM(E&M) I/C Central Mining, Planning & Design Institute Ltd, Gondwana palace, Kanke Road, Ranchi-834008, FAX-0651-231851/ 231447 ph no. 0651- 230876/422245 which will be subsequently reimbursed by the paying authority on production of documentary evidence. Minimum 10 days advance notice shall be given to inspecting agency/ CMPDIL

(b) The final inspection of the consignment shall be carried out at destination stores which will be arranged by consignee on receipt of the store.

In case during inspection, any item is found not conforming to the specification as per order, the supplier shall have to replace the item free of cost to WCL. WCL shall reserve the right to short close the supply or cancel the contract in such situations.

3. **Guarantee / Warranty:** Warranty in respect to sub standard material and poor workmanship, faulty design (excluding normal wear and tear) for manufacturing defect should be valid for a period of 12 months from the date of commissioning / fitment OR 18 months from the date of receipt and acceptance of the materials at destination stores, whichever is earlier. Defective item will be replaced free of cost.

Warranty replacement should be completed within one month from the date of claim. All cases of warranty will be decided on the basis of Joint inspection of the failed item held between user's representative and the manufacturer's representative.
