In case pre dispatch inspection by the representative of CMPDIL, The inspection fee as applicable at the time of inspection (presently inspection charges is @ 1% on the Free at Site price (Basic + Fright + Insurance, P&F etc ) + applicable GST (presently @ 18% ) shall be initially paid by vendor by the inspecting agency.
