1.1 This contract is governed by the [General Terms and Conditions](#), conditions stipulated to this Product/Service as provided in the Marketplace.

1.2 This Contract between the Seller and the Buyer, is for the supply of the Goods and/ or Services, detailed in the schedule above, in accordance with the General Terms and Conditions (GTC) unless otherwise superseded by Goods / Services specific Special Terms and Conditions (STC) and/ or BID/Reverse Auction Additional Terms and Conditions (ATC), as applicable

2. Buyer Added Bid Specific Terms and Conditions-

ADDITIONAL TECHNICAL SPECIFICATIONS OF INDUSTRIAL SAFETY HELMET AS PER IS-2925-1984

1. ISI Safety Helmet in one piece made of High-Density Polythene powder BIS marked and manufactured as per IS-2925-1984 (with amendments done in the year 1988, 1999, 2000 and 2002) with latest amendments if any of the Bureau of Indian standards and confirming to latest DGMS circular no 3 dated 14.08.2014.
2. The helmet must be completely fitted with adjustable headband, chin strap, cable grip, Lamp bracket, cradle etc as per IS-2925/1984. The material used in construction shall be of approved type as per IS-2925/1984 and shall be sweat resistance and shall not cause skin diseases.
3. The helmet should be approved by BIS for which bidder is required to submit duly self-authenticated and self-attested copy of BIS license valid on date of tender opening.
4. The headband of industrial safety helmet should be in range of 540mm to 600mm with a tolerance of ± 10 mm.
5. The shape, construction, harness, cradle, brim, peak etc shall conform to IS 2925-1984 with latest amendments
6. Width of cradle strap should not be less than 19mm.
7. Head band's wearing height should not less 80mm. The width of headband should not less than 30mm.
8. Helmet shall be suitable for use in Mines and shall have not less than 03 numbers of ventilation holes on each side of Helmet. Diameter of any hole shall not exceed 6mm nor the edges of adjacent holes closer than 15mm. Total aggregate area of holes shall not exceed 300mm².
9. Fluorescent strip should be provided on both side of helmet for visibility of helmet during darkness.
10. Each helmet shall have permanently marked with the manufacturer name, model, Size, year and month of manufacture.
11. Each helmet shall also bear marking of BIS license and relevant BIS number along with a declaration stating that it is "Suitable for use in mines"
12. Each Helmet shall bear "Coal India Limited" Logo on front side of helmet.:

13. Mass of the helmet without attachment shall be not exceeding 350 gm.
14. The helmet should have following properties as per IS-2925/1984.
 - a. Flammability resistance
 - b. Electrical resistance
15. The helmet shall not absorb water more than 5% of its mass.

Documents to be uploaded by Bidder with the offer:

- a. Valid BIS License.
- b. The bidder shall submit declaration stating that it is "suitable for use in mines".
- c. Test Report as per IS-2925(with latest amendment if any) from any Govt. Test House / Govt. approved laboratory.

Documents to be submitted along with each lot of supply:

- a. Test Report as per IS-2925(with latest amendment if any) from any Govt. Test House / Govt. approved laboratory.
- b. Valid BIS License.
- c. The bidder shall submit declaration stating that it is "suitable for use in mines".
- d. Guarantee/Warranty certificate as per guarantee /warranty clause.

PROVENESS CRITERIA:-

- a. The item to be offered by the bidder shall be considered to be proven provided offered make of ISI make Safety Helmet confirming to IS 2925-1984 with latest amendment have been supplied during the latest 5 years from the date of bid opening against order of CIL and its subsidiaries, other PSU, Government Department and private organizations and their performance has been found satisfactory during the warranty period.
- b. In case, the performance Report of the End-User is not available, the bidder shall submit self-certificate in the following format, along with proof of Payment against the Purchase order(S) / Rate Contract(S)**
"The items covered in the Purchase Order(S)/Rate Contract(S) copies enclosed with our offer have been fully executed and have performed satisfactorily as per the provisions of respective Purchase Order(S)/Rate Contract(S) and all the complaints/claim(s) lodged by the purchaser, if any, have been attended to and no complaints / claims are pending".
- c. Startups and MSEs are exempted from prior experience criteria (as per Clause 4.a) and should submit proof of establishing the quantity assurance and technical capability for tendered item issued by the statutory authority as per NIT.**

The certificate should clearly indicate that firm is a MICRO and Small Enterprises. Firms should upload the scanned copy of self- attested valid registration certificate with above authority along techno-commercial bid.

Delivery Period: Delivery is to be done in two stages

- a. 50% of the quantity is to be supplied within two months from the date of supply order.
- b. Balance 50% quantity within 4 months from the date of supply order but after completion of first phase of delivery i.e delivery starts after two months. The delivery period shall be reckoned from the 7th (seventh) day of the order placed.

Guarantee /Warranty Clause : Bidder shall be fully responsible for the manufacturer's warranty in respect of proper design, quality, workmanship of the miners safety helmet for a period of 12 months from the date of receipt and acceptance of the materials at the ultimate destination .In case the items supplied are found to be defective, ingenuine and not as per our specification all such items shall have to be replaced free of cost immediately.

2.3 Purchase Preference (Centre):

Procurement under this bid is reserved for purchase from Micro and Small Enterprises whose credentials are validated online through Udyog Aadhaar for that product category. If the bidder wants to avail the reservation benefit, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service.
