1. **Prices:** The prices are FIRM on F.O.R. destination basis inclusive of Packing, forwarding, freight and Insurance charges upto destination stores.

2. **Goods and Service Tax (GST) :** GST shall be paid extra on the basic price, as applicable on the date of supply, within the stipulated delivery period. The present rate of GST is @ 18% which comprises of 9% SGST and 9% CGST

You shall submit the GST compliant Invoice as per the GST rules, indicating all the details as required as per the GST rules, including the HSN code, components of CGST / SGST / IGST(as applicable) etc, which shall enable WCL to avail the Input Tax Credit Set off as per the GST rules. The ITC set off against the GST shall be availed by the Paying Authority, as per the GST rules

3. **Delivery:** 10 sets to be supplied within 3 months from date of placement of supply order and shall be completed at the rate of 10 sets per months thereafter. Early delivery is acceptable. The delivery period shall be reckoned from 7th day of order date.

10. **Mode of dispatch:** All the stores securely packed are to be dispatched by road transport to the consignee on Freight paid basis.
11. **Security Deposit: Not applicable being a Govt PSU**
12. **Performance Bank Guarantee:** You shall submit the Performance Bank Guarantee for the amount equivalent to 10% of the landed value of the contract i.e. Rs.44,82,112.00 (Rupees forty four lakhs eighty two thousand one hundred and twelve only). The Bank Guarantee shall be valid for a period of 30 months from the date of receipt and acceptance of the materials to cover the Guarantee / Warranty Period. The PBG shall be released after satisfactory completion of the Guarantee / Warranty period upon confirmation of GM(Excv), WCL Hqrs or extended as deemed fit. The format of Performance Bank Guarantee is attached as Annexure-B
13. **Guarantee/ Warranty:** You shall be fully responsible in respect of proper design, quality and workmanship of ordered Under Carriage set and shall furnish the manufacturers composite guarantee for the complete set for satisfactory performance of 4500 working hours from date of fitment or 24 months from date of receipt and acceptance of material whichever is earlier. If any defects are found due to faulty design or workmanship supplier will replace the defective parts free of cost at site within 30 days of such intimation by the user.
- (b) **Premature Failures:** (i) During premature failure skilled / unskilled manpower will be provided by WCL, only for removal and fitment of Under carriage components on the equipments.

(ii) In case of premature failure you will depute technical representative for joint inspection within 48 hours of on receipt of intimation, before removal / replacement of components. Intimation will be sent to you either by telephone / fax or letter.

(iii) You will not be held responsible for premature failure during warranty period following cases:

- Defect / damages arises out of dozing beyond its rated capacity
- Damages due to accidents
- Non-adherence to maintenance schedule as per OEM recommendation

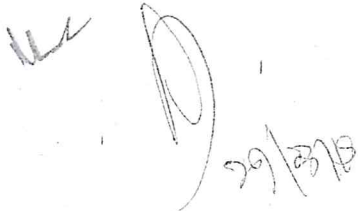
(c) However to avoid any premature failure due to operation / maintenance, following precautions will be taken by the projects in WCL.

- i. Periodical cleaning of Under carriage will be carried out to avoid jamming of rollers on mud during operations
- ii. Track tension will be properly maintained and adjusted whenever required. Both the track shoes assembly / track group will be adjusted to the same tension
- iii. The torque of the track shoes will be checked and maintained periodically as per operation and maintenance schedule of OEM
- iv. Long reverse marching of dozer shall be avoided as far as possible
- v. Pivot turning of Dozer will be avoided. Turning is to be made with largest possible radius as far as possible.

Periodical Inspections: First such inspection should be carried out before 500 working hours and subsequently it may be carried out on every 1000 working hours for all supplied Under carriage sets. Joint inspection report has to prepared at the time of every periodical inspection, which should be duly signed by technical representative of the supplier. Project Engineer and Staff Officer (Excvt) of concerned area .

14. Liquidated Damages & Risk Purchase clause: - In the event of failure to deliver or dispatch the stores within the stipulated date / period in accordance with the samples and/or specification mentioned in the supply order, and in event of breach of any terms and conditions mentioned in the supply order, Coal India Limited shall have the right,

- a) To recover from the successful bidder as agreed liquidated damages, a sum not less than 0.5%(half percent) of the price of any stores which the successful bidder has not been able to supply as aforesaid for each week or part of a week during which the delivery of such stores may be in arrears limited to 10% can be increased to 15% at the discretion of Head of MM Division.
- b) To purchase elsewhere, after due notice to the successful bidder on the account and at the risk of the defaulting supplier the stores not supplied or others of a similar description without canceling the supply order in respect of the consignment not yet due for supply, or
- c) To cancel the supply order or a portion thereof, and if so desired to purchase the stores at the risk and cost of the defaulting supplier and also-
- d) To extend the period of delivery with or without penalty as may be considered fit and proper, the penalty, if imposed shall not be more than the agreed Liquidated Damages referred to in clause (a) above.
- e) To forfeit the security deposit full or in part.
- f) Whenever under this contract a sum of money is recoverable from any payable by the supplier, Coal India Limited and its subsidiary companies shall be entitled to recover such sum by appropriating, in part or in whole by deducting any sum from any other contract should this sum be not sufficient to cover the full amount recoverable. The successful bidder shall pay Coal India Limited and its subsidiary companies on demand the remaining balance. The supplier shall not be entitled to any gain on any such purchase.

- 15. SUBMISSION OF BILLS:** The following documents are to be submitted along with original bills as per terms of the supply order to the consignee.
- (i) Pre-receipted and stamped Tax Invoice as per GST rules
 - (ii) Consignment note / RR/ LR in original (if applicable).
 - (iii) E-Way Bill (if applicable) as per the GST rules
 - (iv) Warranty / Guarantee certificate
 - (v) Fitment Guarantee Certificate
 - (vi) Any other document as specified in the order, if applicable.
- 16. Force Majeure Clause:** If the execution of the contract/supply order is delayed beyond the period stipulated in the contract/supply order as a result of outbreak of hostilities, declaration of an embargo or blockade, or fire, flood, acts of nature or any other contingency beyond the supplier's control due to act of God then Coal India Limited or its subsidiary companies may allow such additional time by extending the delivery period, as it considers to be justified by the circumstances of the case and its decision shall be final. If and when additional time is granted by the Coal India Limited and its subsidiary companies, the contract/supply order shall be read and understood as if it had contained from its inception the delivery date as extended.
- 17. Price Certificate:** You shall certify in your invoice in the following format
- "It is certified that the prices charged indicated in this invoice does not exceed the lowest price at which we sell or offer to sell or offer to sell the stores of identical description to any other organization during the period of contract"
- 18. PRICE FALL CLAUSE:** You undertake that you have not supplied / is not supplying similar products / systems or sub systems at a price lower than that offered in the present bid in respect of any other ministry / department of Govt of India or a PSU and if it is found that at any stage that similar product / system or subsystem was supplied by you to any other ministry / department of Govt of India or a PSU at a lower price, then that very price, with due allowance for the elapsed time, will be applicable to the present case and the difference in the cost would be refunded by you to WCL. A certificate to this effect shall be submitted by you.
- 19. Fitment Guarantee certificate:** You shall have to submit a fitment guarantee certificate that the supplied products are exact replacement of /fully interchangeable to the Original parts and will fit and function on the equipment for which these are intended for without any modification. This fitment guarantee certificate is required along with manufacturer test certificate at the time of supply.
- 20. TECHNICAL SUPPORT SERVICE :** You will provide following technical support service for the ordered items.
1. Your representative should be available at the time of commissioning of the ordered items.
 2. Your representative must visit as and when required basis to provide technical support to the Areas of WCL for smooth running of the equipments
- 21. General Terms and Conditions:** This order shall also be governed by the General Terms and conditions of supply of stores attached as Annexure-A, unless and otherwise specified above.
- 22. Identification mark:** You should mark your identification mark or logo on non wearable surface of the products
- 22. Integrity Pact:** Integrity Pact duly signed by you and furnished by you alongwith the offer shall be valid and applicable for this contract.
