**TECHNICAL SPECIFICATIONS OF MINING TIMBER:
TECHNICAL SPECIFICATIONS:**

1	SIZE:: Mining Timber of different sizes shall be as under:-
Item no	SIZES of Hardwood Sawn Sleepers
1	Hardwood Sawn Sleepers 10cm x 10cm x 1.2 mtr long
2	Hardwood Sawn Sleepers 10cm x 7.5cm x 1.2 mtr long
Item no.	SIZES of Hardwood Pit Props
3	Hardwood Pit props Top girth 31.0 – 41.0 cm, Bottom Girth 46-60 cm, length 3.01 – 4.0 m
4	Hardwood Pit props Top girth 31.0 – 41.0 cm, Bottom Girth 46 – 60 cm, length 4.01 – 5.0 m
2.2	SPECIFICATIONS FOR HARDWOOD SAWN SLEEPER
2.21	Sleepers should be sawn from sound logs of the species of Asha, Kend, Jamun, Dhow, Karan, Dhowza, Hiran, Kaz, Sidha, Panjan, Shirish, Karanu, Saja, Bija and Sal as per IS:4424/67 and amendment no 1 of August 1992 and subsequent amendments
2.22	They should be straight and without bend or twist with faces square to one another
2.23	Particular care should be taken that the wood in the sleepers is free from serious cracks split ends and large knots and free from anything near the rail seat, which may interfere while driving or screwing the sleepers
2.24	There is no provision of tolerance in the dimensions of sawn sleeper
2.3	SPECIFICATIONS FOR PROPS (Assorted sizes)
2.31	These should be brand new / freshly cut during span of one year from the date of supply
2.32	Hard wood species acceptable are Asha, Kend, Jamun, Dhow, Karan, Dhowza, Hiran, Kaz, Sidha, Panjan, Shirish, Karanu, Saja, Bija and Sal as per IS:4424/67 and amendment no 1 of August 1992 and subsequent amendments
2.33	In one plane up to two bends in props may be accepted if they are straight. A perpendicular dip from a thread outside of two ends of a bend to the point on the props showing maximum dip from the thread should not exceed 1" and 6" length of props. For checking up the dip, a thread should spread from end to end of the prop on the side of the cavities of the bends. Top 60 cms to 90 cms of the prop should be free from bends
2.34	Sun cracks on the body of the props should not be more than 1" per foot length i.e. not more than 1 ¼" on a prop of 18' and may not be deeper than 1/3" of the diameter at the point

2.35	Knots should be properly dressed. Large live knots covering more than 1/5 of the circumference of the prop at the section are not acceptable. Small line knots properly dressed may be accepted provided two or more such knots are not grouped together to weaken the props. Dead and rotten knots in props are not acceptable.
2.36	The props should be free from borers
2.4	Tolerance
2.41	The girth of props will be measured at the extreme top and bottom ends and tolerance of +/-1 cm will be allowed in the same as per IS:3337/1978
2.42	There is no provision of tolerance in the length of props
2.43	The girth of the props will be measured under bark and away from knots or swelling or irregularities

Guarantee / Warranty : You shall be fully responsible for the quality and quantity of the materials supplied. In case the items supplied are found to be defective and not to the specifications, they shall replace all such items free of cost immediately
