

| 2.2.1 | Sleepers should be sawn from sound logs of the species of Asha, Kend, Jamun, Dhow, Karan, Dhowza, Hiran, Kaz, Sidha, Panjan, Shirish, Karanu, Saja, Bija and Sal as per IS:4424/67 and amendment no 1 of August 1992 and subsequent amendments |
| 2.2.2 | They should be straight and without bend or twist with faces square to one another |
| 2.2.3 | Particular care should be taken that the wood in the sleepers is free from serious cracks split ends and large knots and free from anything near the rail seat, which may interfere while driving or screwing the sleepers |
| 2.2.4 | There is no provision of tolerance in the dimensions of sawn sleeper |
