Dust masks are provided to personnel working in dusty areas and control measures are being taken against dust generation by providing regular water spraying arrangement at the workings, and Adequate training is being imparted to worker and SOPs (Safe operating procedures) are distributed among workers giving information on safety and health aspects. Periodical medical examination is done once in five years.
