2. In view of the typing errors in Hindi version of question paper for the post of Surveyor (Mining) T&S Grade-B, 3 (Three) grace marks have been awarded to all candidates for following questions.
 - a) Question no. 51 of SET A, question no.26 of SET B, question no. 1 of SET C, and question no. 76 of SET D.
 - b) Question no. 67 of SET A, question no.42 of SET B, question no. 17 of SET C, and question no. 92 of SET D.
 - c) Question no. 21 of SET A, question no.96 of SET B, question no. 71 of SET C, and question no. 46 of SET D.
3. The answer key for Set D question paper of Mining Sirdar T&S Grade -C uploaded in WCL website the answer for question no. 41, was mentioned as '(c)' due to typing error. The correct answer option is '(b) seven' has been considered for evaluation.
