With reference above, against the Open Tender vide no: WCL-hq-pur-rb-e079-2019-20 (Tender id no: 2019_WCL_150529_1) for Supply, installation & commissioning of Digital VHF handheld Transceiver (Walkie Talkie) Sets and Repeaters along with all accessories and CAMC for a period of 5 years, opened on 21-10-2019, you have submitted your offer vide bid no: 450229 dt. 12-10-2019. While processing the tender, price justification was sought from you for the tendered items vide our email dt. 28-01-2020 against which you have vide your letter no: IS/MM/WCL/2020 dt. 04-02-2020 submitted the copy of recent supply order no: 1200761841 / N202 dt. 09-09-2019 said to have been received from M/s. ACC Ltd towards price justification for the tendered items.

For verification of the authenticity of the Order no: 1200761841 / N202 dt. 09-09-2019 submitted by you, a letter vide no: 1448 dt. 14-02-2020 was sent to the Order issuing authority of M/s. ACC Ltd . In reply to our letter the concerned order issuing authority of M/s. ACC Ltd vide email dt. 19-02-2020 has enclosed the copy of Supply Order bearing no: 1200761841 / N202 dt. 09-09-2019 placed by them on you for our perusal.

From the order copy placed by M/s. ACC Ltd on you, it is noted that the description of Items, price details covered in the supply order submitted by M/s. ACC Ltd are different from the Item description and price details indicated in the supply order copy submitted by you as indicated below, while the other details like SO no, date, offer no, offer date etc., remained same.

From the above, it is evident that you have submitted the fake / tampered document during the evaluation process of the tender which falls under the category of "Willful suppression of facts or furnishing of wrong information, false declaration or manipulated or forged documents." as per cl no: 6.13.2 (v) of the CIL Purchase Manual and liable for penal action.

In view of the above charges against you for "Willful suppression of facts , furnishing wrong information and furnishing manipulated & forged documents", a show cause notice vide no: 326 dt. 14-08-2020 was issued to you for explaining why your firm should not be banned for a specified period as per the provisions of CIL Purchase Manual 2020, with an advise to you to furnish your written statement of defense in this regard within 21 days from the date of issue of this notice.

You have submitted your reply vide no: IS/234/WCL/2020 dt. 07-09-2020. The contents of the reply has been examined and it has been observed that you have not submitted a satisfactory reply to the show cause notice and evaded giving specific reply and hence it is proved beyond doubt that you have committed the misconduct as mentioned above and you are liable for penal action viz Banning of Business as per the terms of the NIT and provisions of CIL Purchase Manual under cl no: 6.13.2(v)

In view of the above, all the business dealings with your organization is hereby banned in Western Coalfields Limited for a period of 02 (two) years from the date of issue of this banning order as per the provisions of CIL Purchase Manual under cl no: 6.13.2(v)
