i.	Topsoil should be stacked properly within proper slope at earmarked site (s) and should not be kept active and shall be used for reclamation and development of green belt.	Complied. As it is an under-ground mine, very little quantity of topsoil has been removed during excavation of incline mouth. As informed same has been used for green belt development.
ii.	Garland drains (size, gradient & length) around the safety areas such as mine shaft and low-lying areas to prevent mine inundation and sump capacity should be designed keeping 50% safety margin over and above the peak sudden rainfall and maximum discharge in the area adjoining the mines site and to drain the water away from mine workings. Sump capacity should also provide adequate retention period to allow proper settling of silt material.	PA agreed to comply with. As mine is under development stage and drains have been provided at mouth of the incline to avoid water flow into the mine during rainy season. After mine development phase, sump will be created in the underground for setting of silt.

The density of the trees should be around 2500 plants per ha.	PA agreed to comply with due course of time as mine is under development stage at present. As this is an Underground mine, PA is having limited surface rights. It is submitted that greenbelt will be developed at mines office, other surface infrastructure, colony etc.




