CFDs in its 288th CFDs Meeting held on 25th July 2022, approved the below Interpretation of Medical Attendance Rules, related to Pre-employment Medical examination given in Chapter-VIII.

The interpretations are as follows:

Clause No.	Clause Related To	Existing Provision	Interpretation
8.xiv	Blood Sugar	Urine should be examined particularly for the presence of sugar and albumin.	Candidates suffering from Diabetes without any organ damage involvement will be considered FIT for employment.
8.vii	Blood Pressure	Blood pressure should be normal in recumbent posture.	Candidates suffering from blood pressure, which is not considered as Severe hypertension (Systolic 180mm of Hg or higher and/or Diastolic 110 mm of Hg or Higher) or suffering from blood pressure without any organ damage involvement, will be considered FIT for employment.
8.xiii.d	Colour blindness	Tests also should be done for colour blindness.	All persons being considered for employment will compulsorily be examined for Colour Blindness. However, Colour Blindness will be acceptable for employment under Group B.

The above interpretation will be effective prospectively.
