Sub: Inclusion of all Non Coking coal sources under Mine Specific pricing Category w.e.f. 00:00 Hrs of 12.04.2023

All existing non coking coal sources of WCL being charged for supplies at CIL notified prices are hereby included under Mine Specific Pricing category. For supply of coal from all Non-Cost Plus Non-Coking coal sources of WCL, the Mine Specific Prices notified by WCL from time to time shall be applicable to all buyers of Power and Non-Power Sector with effect from 00:00 hours of 12.04.2023. At present, Mine Specific Prices notified by WCL vide Notice No. NGP/WCL/M&S/Comml/2020/626 Dated 28.11.2020 are in vogue.

In addition to the Mine Specific Notified price of coal, all the elements of other charges, taxes and levies as are presently charged shall continue to remain applicable as per the existing notification of CIL/WCL and as notified from time to time.

The existing customers being supplied coal at CIL notified prices from Non Coking coal mines under different schemes are being offered the following one time dispensation:-

- a) <u>Linkage Auction</u>: The Linkage Auction consumers having FSA for supply of coal shall be required to pay the Mine Specific Notified price along with percentage of winning premium on revised price. In case revised price is not acceptable, consumer may opt for Exit option even if the Lock-in period of 2 years of FSA has not been completed. The last date for applying for exit from the FSA shall be 26.04.2023.
- b) <u>E-Auction</u>: Customers of E-Auction will be required to pay the winning premium over and above the Mine Specific Notified Price or they may opt for refund of coal value along with EMD. Refund of EMD will be allowed to all such consumers who opt for refund.
- c) Other FSA:- Delivery Order issued under any other scheme will attract Mine Specific Notified price for despatches from 00:00 Hrs of 12.04.2023 or such consumer may opt for refund.
