

Sub: Applicability of Section 9B and 9C of the Mines and Minerals (Development and Regulation) Amendment Act.2015 .

Please refer to our earlier letter no.NGP/WCL/GM(F)/Tax/467 dated 30.05.2016 regarding applicability of Section 9B and 9C of the Mines and Minerals (Development and Regulation) Amendment Act.2015 . In terms of latest Gazette Notification , following are to be followed :-

1. Applicable date for contribution to NMET established by Central Government under Sec-9C of Mines and Minerals (Development and Regulation) Amendment Act,2015 will be 14.08.2015 .
2. Applicable date for contribution to District Mineral Foundation on Royalty under Sec.9B for the mines situated in the State of Madhya Pradesh will be 12.01.2015 . Instruction for enforcement of contribution to District Mineral Foundation on Royalty under Sec.9B for State of Madhya Pradesh was given to areas situated in the state of Madhya Pradesh for raising bills from 24.02.2016 onwards and also raising bills for contribution to District Mineral Foundation on Royalty under Sec-9B for state of Madhya Pradesh from 20.10.2015 to 23.02.2016 for payment to state authority . Hence , in terms of recent notification dated 31.08.2016 , bills has to be raised for contribution to District Mineral Foundation on Royalty under Sec.9B for State of Madhya Pradesh from 12.01.2015 to 19.10.2015 for payment to state authority .
3. Applicable date for Contribution towards District Mineral Foundation on Royalty under Sec.9B for the mines situated in the State of Maharashtra will be 12.01.2015 . Hence , bills are to be raised for contribution to District Mineral Foundation on Royalty under Sec-9B for the state of Maharashtra from 12.01.2015 to 31.08.2016 as an arrears and from 01.09.2016 onwards regular bills is to be raised for contribution to District Mineral Foundation on Royalty under Sec-9B for the state of Maharashtra in terms of notification of Maharashtra Govt. dated 07.09.2016 .
4. As per the notifications , rate for contribution to NMET is 2% of the Royalty and rate for contribution to District Mineral Foundation for the State of Madhya Pradesh as well as Maharashtra is 30% of Royalty .
5. Payment towards contribution to District Mineral Foundation on Royalty under Sec-9B for arrears will be on realization basis .
