**Issuance of Sale Orders for the Quantity booked under FSA/Spot e-Auction dtd 18.01.2022 from Amalgamated Inder-Kamptee Deep OCM instead of Inder & Kamptee OCM.**

Kamptee Conv UG to OCM and Inder Conv UG to OCM had been merged as Amalgamated Inder Kamptee Deep OCM and provisional grades of Amalgamated Inder-Kamptee Deep OC Mine had been notified vide Notice Ref No. Prov Gr. Cert. No. NAG/2021-22/102/5167 dated 27.01.2022 w.e.f 01.02.2022.

As such bidders, who have booked coal under Spot e-Auction dtd 18.01.2022 from Inder Conv UG to OC Mine (G10G11 Mix) and customers allocated coal under Non Power FSA holders (excluding FSAs executed through Linkage Auction) against the month of Jan'2022 from Kamptee Conv UG to OCM (G10G11 Mix) and Inder Conv UG to OCM (G10G11 Mix) shall have the option:

**1. Spot e-Auction:** Bidders are required to give consent **by 12.02.2022** for issuance of Sale Orders from Amalgamated Inder-Kamptee Deep OCM (G10G12 Mix) instead of coal booked from Inder Conv UG to OCM (G10G11 Mix) under Spot e-Auction dtd 18.01.2022 at the same bid price on which auction was concluded. However, any bidder willing to take refund due to non-acceptance of change in grade may ask for refund of coal value alongwith EMD **on or before 12.02.2022**.

**2. FSA:** To give consent letter **by 12.02.2022** for re-allocation of coal quantity against the month of Jan'2022 from Amalgamated Inder-Kamptee Deep OCM (G10G12 Mix) in place of Kamptee Conv UG to OCM (G10G11 Mix) and Inder Conv UG to OCM (G10G11 Mix).
