**NOTICE TO THE ERSTWHILE NON CORE SECTOR / NON POWER CONSUMERS
(INCLUDING CPP)**


All non core sector consumers and Non power consumers (including CPPs) were advised vide this office notice Nos. NGP/WCL/S&M/RS/804-907 dated 5.6.2013 and 964-1017 dated 29.6.2013 to submit the information / documents/ affidavit / certificate for the financial year 2012-13 for verification of the same, before renewal of Coal Supply Agreements.

The Committees constituted vide Office Order Nos..NGP/WCL/S&M/ Coordn/1037 dated 6/8.7.2013 and No. NGP/WCL/S&M/Coordn/132 dated 12.10.2013 to verify the documents submitted by the consumers scrutinised the documents and observed that proper documents have not been submitted and/or submitted documents are not as per the said notice.

Accordingly, the CSA consumers were informed vide notice Nos. NGP/WCL/S&M/RS/1258 dated 7/10.2013 and 1283 dated 22.10.2013 to call on to this office to understand from the Committee, the discrepancies found in the documents submitted by them against which many consumers resubmitted the requisite documents, which has also been scrutinised by the concerned committee, however, it was observed that inspite of clarification, guidelines, discrepancies pointed out by the said committee, the resubmitted documents are still not in order / complete as per the notice.

In order to understand the reasons of non submission of the corrected documents by the consumers, a meeting was called on 13th instant in the office of the undersigned, where the consumers , their representatives, concerned committee members, officers of S&M Dept. were present. During interaction with the consumers, against discrepancies pointwise clarification was given by the concerned committee members, which was agreed by the consumers. Further to this, in order to commence FSA renewal at the earliest, consumers were advised to submit / resubmit corrected documents latest by 16.11.2013, which was also agreed by the CSA consumers.

Once again, the CSA consumers are hereby advised to submit / resubmit the requisite corrected documents latest by 16.11.2013 for further scrutiny by the concerned committee.
