Sub: Rectification of allotment of coal from Temporary Source by Road Mode

In reference to this office Notice No. NGP/WCL/M&S/2018/1358 Dated 16.10.2018, regarding allotment of coal from Temporary Source by Road Mode to NRS Linkage Auction FSA consumers against MSQ for the month of Aug'2018, it may be noted that the last date for applying for change of Mode against MSQ of Aug'18 was 16th July'2018.

However, JK Papers Limited has submitted their applications after due date, which was considered erroneously in offer communicated vide above notice. Hence offer to M/s. JK Papers Limited by temporary road mode for Aug'18 MSQ is hereby cancelled and the coal will be moved by Rail only.

Further, the highest winning premium of Umrer OC by Road Mode in Tranche-IV was 5.78%, which was not considered erroneously in allotment communicated earlier vide our Notice No. NGP/WCL/M&S/2018/1136 Dated 12.09.2018 & Notice No. NGP/WCL/M&S/20181358 Dated 16.10.2018. Hence price applicable for supply of coal from Umrer OC by Road Mode, which was communicated earlier as Rs. 1732/- / Tonne, stands revised to Rs. 1832.11 Per tonne (Revised As delivered price will be Rs. 2849.32/te).

Consumers which were allotted coal from Umrer OC against MSQ for month of July'18 & Aug'18 vide above mentioned notices are requested to deposit the difference of coal value against the MSQ of July'18 and coal value for MSQ of Aug'18 may be deposited as per revised Rate.
