Sub : Coal supply to MSCCFL under Coal Supply Agreement

WCL is releasing coal to M/s Maharashtra State Coop. Consumers Fedn. (MSCCFL) against the Coal Supply Agreement (CSA) executed between WCL and MSCCFL on the strength of the nomination made by your office. As per Clause 3 of the New Coal Distribution Policy (NCDP) dated 18.10.2007 of Govt. of India, Ministry of Coal, the concerned State Govt. would be responsible to ensure that the coal allotted to the State Nominated Agency is distributed to the targetted consumers in a fair and transparent manner and to take appropriate action to prevent any misuse.

In accordance with the above, provision has been made under Clause 4 of the CSA entered between MSCCFL and WCL that MSCCFL shall submit to the State Govt. the quarterly return giving monthwise, consumerwise, unitwise details of coal sold to the targetted consumers and other relevant details of such consumers, to enable monitoring of the same by the State Govt.. To facilitate the State Govt. to ensure proper monitoring of the same, WCL has been furnishing to your office the monthly details of coal released to MSCCFL. It is expected that the necessary mechanism for ensuring distribution of coal by MSCCFL. only to the targetted units in the state of Maharashtra is put in place by the concerned authority of the State Govt and the compliance of the same is closely monitored from your end.

Now, we are furnishing herewith the Delivery Orderwise details of the coal released to MSCCFL for the month of Dec. 2013 in the enclosed statement. The total quantity of coal released to MSCCFL for the month of Dec. 2013 is as below :

In view of the above, we once again request you to ensure strict compliance of the provisions of NCDP and CSA to ensure that coal released to MSCCFL is distributed to the targetted consumers for genuine consumption and the coal is not misused in any manner.
