NOTICE TO THE CUSTOMERS

All our customers lifting coal on the basis of road delivery orders issued under e-Auction Schemes and Coal Supply Agreements, are hereby informed that in terms of the Notifications issued by Govt. of India, the following changes in the rates of Clean Energy Cess (CEC) and Central Excise Duty (CED) payable on coal are effective w.e.f., 00 hrs. of 1.3.2015.

1. Clean Energy Cess increased from Rs. 100/- per tonne to Rs. 200/- per tonne
2. Excise Duty basic rate will be 6% only and Education & Higher Education Cess will be zero


Accordingly, all despatches w.e.f. 00 hrs of 1.3.2015 are to be charged in accordance with the above revised rates.

In case of value paid orders already issued with pre revised rates (i.e. at the rates applicable as on 28.2.2015), the differential amount on account of revision in the rates as stated above, towards the balance quantity as on 00 hrs. of 1.3.2015, shall be collected from the customers at our respective Areas. In the event of non receipt of differential payment from the customers, the balance quantity to be delivered against the delivery orders as on 00 hrs. of 1.3.2015 shall be reduced in proportion to the revision in the rates.

In such cases, where the issue of delivery orders are pending against the payments already made by the customers upto 28.2.2015, the delivery orders shall now be issued as per the rates applicable as on 28.2.2015, but the customers shall be required to deposit the additional payment towards the revision of rates as stated above at the Areas and in case of non submission of differential payment at the areas, the released quantities against the D.O.s shall be reduced by the Areas in proportion to the revision in rates.

The last date for submission of payment by the customers towards the quantities secured by them in the Spot e-Auction held on 19.2.2015 is 3rd instant and these customers are advised to submit the payment with the revised rates of CEC and CED as stated above.

All other taxes, duties, levies etc., shall be charged as applicable.
