### **NOTICE TO THE CSA CUSTOMERS**

#### **Sub: Customer-wise, source-wise allocation of coal for the month of Apr'2019 in the 2<sup>nd</sup> round of allocation**

In response to our Notice No. NGP/WCL/M&S/RS/14 dated 09/10.04.2019, application of 7 Nos of CSA holders who had made application from mapped sources has been considered for allocation of coal for Apr'2019 in the second round. Against the total applied quantity of 27082 tes, allocation of 23471 tes has been made in the second round.

The customer-wise, source-wise, size/grade-wise allocations of coal finalised in this round is displayed herewith as **Statement 'A-2'**. The details of source-wise quantity offered, grade-wise, customer-wise quantity applied and quantity allocated along with the ratio applied for each customer for arriving at the allocation against the applied quantity are given in **Statement 'B-2'** displayed herewith. The customer-wise, source-wise, size/grade-wise allocations made in Round No.1 & 2 together is displayed herewith as **Statement 'D'**.

The customers in whose case the applied quantity has not been allocated in full and also the customers who failed to make application in the 1<sup>st</sup> and 2<sup>nd</sup> rounds can submit their application for allocation by 04:00 pm of 15.04.2019. The consumer can also indicate the desired source from which balance quantity is required in case of pro rata allocation in any source in the third round. The details of source-wise, grade-wise quantity available for allocation in the 3<sup>rd</sup> round of allocation is also displayed herewith as **'Statement 'C-2'**. In case of those consumers who could not be allocated the entire or part of applied quantity from the source(s) of their choice in the third round, the balance quantities will be allocated by WCL from the available sources as per the consumer's entitled grade. This shall be the final round of allocation. The quantities allocated against the 3<sup>rd</sup> and final round of allocation shall be displayed in our website on 16.04.2019.
