In reference to Spot e-auction Scheme 2007 of CIL (including relevant updates/notifications made by CIL/coal company time to time) the following amendment is hereby issued:

The rakes which are not loaded within the loading validity will lapse and the EMD for the relevant quantity will be refunded.</b>
