Sub: Exit of FSA consumers under NRS Linkage Auction in view of Mine Specific Pricing wef 02.11.2019

WCL vide Notice No. WCL/GM(M&S)/2019/307 dated 01.11.2019 had notified 11 mines as Mine Specific sources. Further, the grade-wise Notified Price for Power and Non-Power from the Mine Specific Sources was also notified vide this notice. WCL vide Notice No. NGP/WCL/M&S/Comml/1438 dated 02.11.2019 had given an option of Exit to the consumers of Linkage Auction who do not agree to the Mine Specific Price, considering the price impact.

Accordingly, WCL vide Notice No NGP/WCL/M&S/Comml/472 dated 24.09.2020 had granted Exit to 42 consumers who did not agree for Mine Specific price. Further requests were received in WCL for Exit in terms of WCL Notice No. NGP/WCL/M&S/Comml/1438 dated 02.11.2019. The Exit Requests of 15 FSA holders seeking exit in view of WCL Notice No. NGP/WCL/M&S/Comml/ 1438 dated 02.11.2019 is approved. However, compensation due to short lifting, if any, shall be payable by these FSA holders from the period of signing of the FSA till introduction of Mine Specific Pricing i.e. 02.11.2019. The list of these 15 FSA holders is enclosed herewith.

It is further notified that no further exit requests shall be considered against WCL Notice No. WCL/GM(M&S)/ Comml/1438 dt. 02.11.2019.
