CIL vide its notice no CIL/ M&S/ 218 dt 07.06.2021 (copy enclosed at **annex - I**) have informed the about waiver of Performance Incentive for Power Sector Consumers under FSAs.

The relevant extract of the notice is as given below:

- Waiver of Performance Incentive (PI) can be permitted to power plants if all the undisputed outstanding dues are cleared and they make advance payments either in 3 instalments in a month or through Irrevocable Letter of Credit (IRLC) or through Usance LC throughout the financial year without any default as per the provisions of the FSA.
- In case of default of point (i) no dispensation shall be given and complete PI shall be charged.
- This would be applicable to both Government and Private Power Plant taking coal vide Pre NCDP scheme for Power Sedor/ Post NCDP Scheme (LOA route) for Power Sector/ SHAKTI A(i)/ SHAKTI B(i)/ SHAKTI B(ii) and SHAKTI B(iii) Schemes.
- The above provision is only applicable to power sector and not applicable for non power consumers.
- The other FSA provisions inter-alia modalities for Billing, Claims & Payments etc shall remain unchanged.
- This would be applicable for FY 2021-22 and onwards. The clause shall be reviewed subsequently to FY 2021-22.

### NOTICE TO POWER SECTOR CONSUMERS

#### Sub: Waiver of Performance Incentive for Power Sector Consumers under FSAs

Power Sector consumers are hereby informed that CIL Board in its 422<sup>nd</sup> meeting held on 27.05.2021 approved waiver of Performance Incentive for Power Sector Consumers in cases where advance payment is made or payments made through IRLC / Usance LC. The relevant extract of the meeting is quoted below:

" (i) Waiver of Performance Incentive (PI) can be permitted to power plants if all the undisputed outstanding dues are cleared and they make advance payments either in 3 instalments in a month or through Irrevocable Letter of Credit (IRLC) or through Usance LC throughout the financial year without any default as per the provisions of the FSA.

(ii) In case of default of point (i) no dispensation shall be given and complete PI shall be charged.


(iii) This would be applicable to both Government and Private Power Plants taking coal vide Pre NCDP scheme for Power Sector/Post NCDP Scheme (LOA route) for Power Sector/SHAKTI A(i)/SHAKTI B(i)/SHAKTI B(ii) and SHAKTI B(iii) Schemes.

(iv) The above provision is only applicable to power sector and not applicable for non-power consumers.

(v) The other FSA provisions inter-alia modalities for Billing, Claims & Payments etc. shall remain unchanged.

(vi) This would be applicable for FY 2021-22 and onwards. The Clause shall be reviewed subsequent to FY 2021-22."
