**Sub:- Revision of Surface Transportation Charges from pit-head to loading point of coal for all the existing lead distance w.e.f. 00:00 hrs of 25.06.2022**

All the customers/ bidders of WCL are hereby informed that vide notice no. NGP/WCL/GM(M&S)/208 dt 24.06.2022 of GM (M&S), WCL (copy enclosed as Annexure-I), the Surface Transportation Charges from pit head to loading point of coal for all the existing lead distances has been revised with effect from 00:00 hrs of 25.06.2022.
