All the Non Power CSA Consumers (including CPP/LoA/Linkage Auction) are requested to make the payment as per FSA provisions & **Notice No. WCL/NGP/M&S/Oprn/320 dated 10.06.2019** & Notice **No.WCL/NGP/M&S/COMM/1438 Dated 02.11.2019**. Also confirm to concerned section of WCL for movement of rake & ensure submission of Railway freight as per extant Railway Rules, so that indented rakes be moved without fail.

As per Notice NO. WCL/NGP/M&S/sect./573 dt.21/22.06.2018 the advance payment shall be required to be made prior to planning of the rake for movement and for intimation to the Railways. Non payment of coal value in advance shall lead to cancellation of allotted rakes for making way for movement of rakes next in seniority. Consumers are required to regularly visit ODR wise rake outstanding details in FOIS and ensure that coal value for senior most rake in seniority in a specific siding is paid in advance and no correspondence in this regards shall be made or entertained.

In the eventually of cancellation of rakes after allotment due to nondeposition of coal value or cancellation by the consumer, wagon Registration Fee as applicable shall be paid by the consumer.

Therefore it is requested to make the payment of above Rakes immediately, so that the rakes given in daily rake loading plan be loaded positively for smooth movement of Non Core category rakes for liquidating the huge backlog of rakes.
