NOTICE FOR SUCCESSFUL BIDDERS IN THE SPECIAL E –AUCTION FOR POWER PRODUCERS HELD BY CIL ON 30.09.2015

Below given are the procedural modalities for implementation & needful by successful bidders under the special e –auction for power producers held by CIL_on 30.09.2015. pertaining to WCL.

1. <u>Requirement of documents</u>

Bidders shall be required to furnish the following documents.

- i. Confirmation about achievement of COD from CEA on or before consent of WCL is issued for movement of 1st rake.
- ii. Copies of all documents submitted to service provider as per clause 3.1 as per Special e –auction for Power Producers, on or before depositing the coal value for the month of Oct'15. WCL shall be free to ask any clarification /additional documents and failure to comply with the same may lead to suspension of supplies/forfeiture of EMD.
- iii. PPA documents (short term) if they have PPA or if there is no PPA then a confirmation to this effect.
- iv. Copies of the documents must be certified by the authorised person and a photo ID card should also be submitted along with documents.
- v. The bidders are further informed that they must ensure all the aforesaid documents submitted are valid at the time of availing coal supplies and if validity of any of the requisite documents is expiring/expired during such period, then the same be submitted with duly extended validity. In the event of failure to do so, supplies would be kept suspended by WCL in such intervening period and entire responsibility in this regard shall rest with the bidder only. It is also clarified that any quantity which could not be supplied due to failure in this regard shall not be revived and EMD for such lapsed quantity shall be forfeited.

2. Scheduling of rakes against successful bids

Monthly Distribution of Rakes is as per <u>Annexure -1.</u> The monthly distribution of rakes is provisional and it may be modified at the discretion of CIL/WCL.

3.Coal Value for rakes against successful bids :

As delivered price currently applicable for different Sidings is given at Annexure 2.
