:NOTICE FOR THE WEB PORTAL:

Attention of all Power Generators in State, Central sectors as well as IPPs having effective FSA with WCL is drawn to the fact that due to logistics / evacuation constraints coal stock is getting accumulated at some points of the company, as indicated in the table below :

It is proposed to allocate the quantity indicated in the above table to the interested power consumers having long term PPA with DISCOMs in following inter-se-priority. The interested power consumers shall have to evacuate the coal on their own from the stock till the month end. However, the commercial arrangement for such lifting shall be as per the FSA or prevailing arrangement, as applicable.

- (a) Power Plants commissioned before 01.04.2009 having FSAs with the coal companies (upto 90% of pro-rata ACQ upto March, 2015)


(b) Power Plants which have got commissioned after 01.04.2009 and which have FSAs (upto 65% of pro-rata ACQ upto March, 2015)

(c) Power plants which come under the 4660 MW and similarly placed category under 9940 MW on best effort basis.

The interested TPPs falling in the above categories may respond to this notification and confirm the quantity they intend to purchase through applications in the company's letter head and the same be sent by e-mail to gmsmwcl@gmail.com on or before 7th of December,2014.

The consumers having FSAs / FSAs with Side Agreements with WCL for supply of coal only on cost plus basis and similarly placed category under 9940 MW through MOU shall be eligible to apply for allocation of coal only from the cost plus sources indicated in the above list.

WCL shall indicate the consumer-wise, source-wise quantity of coal allocated and the price applicable in the portal on the 10th day after publication of this notice. Consumers are required to start lifting within 7(seven) days from the date of allocation after making necessary commercial arrangements.
