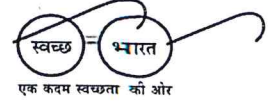

**Sub: Change of mode-Road to Rail pertaining to order booked under Special Forward E-Auction Scheme & under FSAs through NRS Linkage Auction Route**

Ref:

- (i) Letter No. CIL/M&S/1871 dated 23.04.2020 (Pertaining to order booked under Special Forward E-Auction Scheme)
- (ii) Letter No. CIL/M&S/1872 dated 23.04.2020 (Pertaining to order booked under FSAs through NRS Linkage Auction Route)

Vide the aforesaid letters, it has been intimated that CIL Board, in its 402<sup>nd</sup> meeting dated 16.04.2020 has ratified the temporary dispensation for change of mode from road to rail in both cases.


The temporary dispensation was allowed for the period of exigency initially for three (3) months (i.e. April-June 2020) and if required, after review with CIL, for another three (3) months.

As the lockdown imposed across the country has not yet been completely lifted and as situation has not yet normalized due to the continuing pandemic, the impact continues on despatches, especially by road mode.

Keeping in view of the above facts, the competent authority has approved the dispensation for change of mode from road to rail for another three (3) months i.e. from July 2020 to September 2020 as per same terms & conditions as circulated vide the letter nos. as mentioned above.
