This is for the information of all non power sector consumers that, the following has been decided by Railway Board and CIL. Copies of the following communications relevant in this regards are enclosed for ready reference.

- a. Procedure module for supply of rake against non-lapsable indents on account of COVID-19 pandemic – CMP/Policy/2020 dt. 03.07.2020 issued by Director (Rail Movement), Railway Board, Kolkata.
- b. Advice issued to the subsidiaries of CIL by General Manager (M&S)/QC, CIL vide letter no. CIL/M&S/Wagon Loading /488 dated 16.07.2020.

Accordingly modalities are summarized below:

- i. The consumers who wish not to have any movement of coal on account of Covid-19 pandemic shall request the Coal Company (WCL) in advance to keep the indents in abeyance. In the absence of such advance intimation, it shall be deemed that the consumer is willing to accept the supplies against the pending indents.
- ii. On receipt of such requests for non-supply of rakes, WCL shall inform to CR/SCR to keep the indents in respect of those consumers in abeyance. The indents in such cases shall continue to be kept in abeyance until the consumers specifically inform the Coal Company (WCL) that they are ready to avail the supplies.
- iii. During the period the indents are kept in abeyance, the concerned consumers shall not be entitled to file fresh monthly programs.
- iv. The indents so kept in abeyance shall be advised by WCL to CR/SCR for revival only on the specific request of the consumers. They shall be entitled to file fresh monthly programs only after written applications are made by the consumers to the Coal Company (WCL) for reactivation of the indents kept in abeyance.

Sub: Liquidation of heavy arrears of pending industry indents of NRS Consumers.

Dear Sir.

This is in reference to the letter issued by ED (Coal), Ministry of Railways dated 08.07.2020 (copy enclosed) regarding the above-mentioned subject.

In this connection, please refer to the Railway board letter no:2020/TT-V/25/CIL dated 29.06.2020 (copy enclosed) where it was instructed to the Zonal railways that under the present economic circumstances on account of COVID-19 pandemic, not to supply rakes against pending indents of unwilling consumers on specific recommendation by the coal companies.

In this regard, to reduce the overall pending rakes, it has been proposed by Railways

Quote:

"...not to make any fresh 'offer/allotment' to the concerned railways' office for such consignees/consumers whose existing indent have been kept in abeyance on CIL/SCCL recommendations as they are not in a position to accept coal at present. In case, those consumers would require coal, their indents from the "kept in abeyance" list may be revived and loaded."

The above proposal is also agreed by CIL of not putting fresh booking for a particular month if the consumer is unable to take supplies in that month.

Already certain dispensation has been allowed by FDs of CIL in its 232nd meeting for NRS consumers for the year 2020-21(copy enclosed) where point no:3 stipulates as under: Quote:

"The above dispensation of carryover of un-lifted/un booked quantity in a particular month shall be allowed for the entire FY subject to availability of coal at the coal company and within the ceiling of ACQ."

In view of the above, following actions may be taken by the coal companies with infimation to the consumers:

The consumers who wish not to have any movement of coal on account of Covid-19 pandemic shall request the Coal Company in advance to keep the indents in abcyance. In the absence of such advance intimation, it shall be deemed that the consumer is willing to accept the supplies against the pending indents.

ii. On receipt of such requests for non-supply of rakes, the Subsidiary Company shall inform the concerned railway authority to keep the indents in respect of those consumers in abeyance. The indents in such cases shall continue to be kept in abeyance until the consumers specifically inform the Coal Company that they are ready to avail the supplies.

iii. During the period the indents are kept in abeyance, the concerned consumers shall not be entitled to file fresh monthly programmes.

iv. The indents so kept in abeyance shall be advised by the Coal Companies to the Railways for revival only on the specific request of the consumers. They shall be entitled to file fresh monthly programmes only after the written applications are made by the consumers to the Coal Companies for revival/ reactivation of the indents kept in abeyance.

It informed that heavy arrears of industry indents non-lapsable are pending at number of CIL sidings. It is also informed that Railways are having surplus rolling stock, which can be supplied against these pending indents. Letter from CIL and representations from end customers were received requesting for non-supply of coal rakes to the unwilling NRS consumers on account of economic condition developed due to COVID-19 pandemic situation. Taking a considered view, Railways issued instructions to Zonal Railways vide reference above, for not supplying rakes against pending indents of unwilling consumers on specific recommendation by the sponsored CIL subsidiaries/SCCL and a separate field has been created in FOIS system 'Indents kept in abeyance on CIL account' by carrying out necessary software modifications in FOIS/Coal RAS system. Such inactive indents can be revived/ re-activated at the instance of CIL subsidiaries/SCCL when the industry is willing and able to receive the Coal. A procedure order for implementation of above instructions has also been issued by Dir/Rail Movement/Kolkata and circulated to all concerned. The procedure is likely to get implemented in the FOIS system by 10.07.2020.

However, it is felt that the above action alone will not resolve the issue of heavy pending of industry arrears. To address the issue in totality it is requested that Subsidiaries Coal Companies may be advised at your end not to make any fresh 'Offer/allotment' to concerned Railway's office for such Consignees/Consumers whose existing indents have been kept in abeyance on CIL/SCCL recommendations as they are not in a position to accept coal at present. In case they would require coal, their indents from the 'Kept in abeyance' list may be revived and loaded. Zonal Railways have been advised to implement the above guidelines. Coal Companies may undertake necessary procedure changes at their end to keep offers of such consumers available in their records for future reference.

Subject: Decision of 232nd FDs meeting held on 27.06.2020 on dispensation to Non power sector consumers to revalidate shortfall quantity and lift coal to the extent to ACQ under FSA

The 232nd FDs meeting held on 27.06.2020, after detailed deliberation accorded its approval for extending to Non power sector consumers to revalidate shortfall quantity and lift coal to the extent to ACQ under FSA, the relevant portion of which is as follows:

Quote:

- 1. Purchasers who could not offtake the MSQ quantity (Scheduled quantity or SQ as per FSA) during Apr-June 20 under NRS Linkage auction FSA for any reason whatsoever may be allowed to book the unlifted/unbooked quantity in the subsequent months of current FY subject to availability of the coal at the coal company.
- 2. The willing consumers has to submit an undertaking stating that the coal taken under this relaxation shall be utilized against requirement of their EUP and they shall not procure the coal to the extent of such shortfall quantity through import during current FY.
- 3. The above dispensation of carryover of unlifted/unbooked quantity in a particular month shall be allowed for the entire FY subject to availability of coal at the coal company and within the ceiling of ACQ.
- 4. The same dispensation may also be extended for the willing non power FSA consumers other than NRS Linkage auction also to the extent of their ACQ irrespective of Import component under FSA. However, the same shall be allowed subject to fulfillment of all commercial obligation including performance security as per FSA provision.
- 5. The above dispensation shall be optional in nature.

It was decided that the above "relaxations shall be given upto March' 2021 without affecting the committed supply".

Coal companies are requested to take needful action for implementing the above.

Sub: Procedure module for supply of rake against Non-Lapsable indents on account of COVID-19 pandemic.

As per railway board letter no. 2020/TT-V/25/CIL dated 29.06.2020 – Director/RM/Kolkata/Rly Bd has been directed to issue a procedure order for the module – Non Lapsable Indents of the coal consumers who do not want rake supply at present on account of COVID-19 pandemic to be kept in abeyance as inactive indents. With the approval of EDTT (coal)/Rly Bd following procedure order is being issued.

PROCEDURE ORDER :

- Non-lapsable indents of the coal consumers who do not want rake supply at present on account
 of COVID -19 pandemic be kept in abeyance as inactive indents. The -"KEPT IN ABEYANCE AS
 INACTIVE INDENTS" of unwilling consumers and thereafter "REVIVAL/REACTIVATION" is to be
 exercised by Zonal Railways concerned, based on the written request of the concerned sponsored
 CIL subsidiaries/SCCL as detailed below.
- Written request with specific recommendation from the sponsored CIL subsidiaries/SCCL to the Divisional Operating Manager of the concerned Division under concerned Zone signed by an authority not bellow the rank of HOD (GM/SALES etc.) of the concerned sponsored CIL subsidiaries/SCCL, should be made.
- 3. Specific recommendation should entail a request to keep pending Non Lapsable Indents of unwilling consumers which are coming in the seniority list for supply of rake under "KEPT IN ABEYANCE AS INACTIVE INDENTS" in the indented seniority list of such particular siding in Coal RAS/TMS. This written request should clearly mention Siding wise (pilot wise), category wise, customer wise, allotment wise detail giving allotment date and seniority number in the pilot.
- 4. Such, "KEPT IN ABEYANCE AS INACTIVE INDENTS" in Coal RAS/TMS, can be revived/reactivated when concerned sponsored CIL subsidiaries/SCCL again makes a written request for the same signed by an authority not below the rank of HOD (GM/SALES etc.)

- 5. Such request by concerned sponsored CIL subsidiaries/SCCL against a particular indent can only be made ONCE.
- 6. Such request should have a clear written undertaking by the sponsored CIL subsidiaries/SCCL that complete onus for this request to keep indents of unwilling consumers "in abeyance as inactive indents" is vested with sponsored CIL subsidiaries/SCCL and Railways shall not be in any way responsible for deferment of supply of coal to them.
- Sr. DOM of the concerned Division shall mark the indents as requested by concerned sponsored CIL subsidiaries/SCCL as "KEPT IN ABEYANCE AS INACTIVE INDENTS" or "REVIVAL/REACTIVATION" as the case may be in coal RAS/TMS of the concerned division.
- A module in this regard needs to be developed by CRIS. The coal RAS/TMS of divisions should be modified to have following changes:
 - a. Provision to mark an indent as "KEPT IN ABEYANCE AS INACTIVE INDENTS" in Coal RAS/TMS. This must ensure that this indent will not be available for supply of rake. Also this indent will not figure in the list of pending indents. This indent will be available under a separate head – "Indents kept in Abeyance on request of concerned sponsored CIL subsidiaries/SCCL".
 - b. Provision to revive/reactivate such indents that has been kept in abeyance as inactive indents. After revival/reactivation such indents will be restored to its original position.
 - c. Provision to ensure that one indent can be marked as "KEPT IN ABEYANCE AS INACTIVE INDENTS" only ONCE.
- Sr. DOM of the concerned Division shall maintain necessary record and submit periodical report to its Zonal HQ.
