Sub: Offer of Crushed ROM coal exceeding 4600 and not exceeding 4900 kcal/kg GCV (G-9) band on "as is where is basis" for JULY'14 TO SEPT'14.

In order to improve overall coal availability for Power generation , as well as , for stock building at power house end, WCL, intends to offer following quantities of coal from its various sources as per the details given below with the stipulations that the PUs would make their own evacuation arrangement by Road.



The salient terms and conditions, in this regard, will be as under:

- **POWER UTILITIES** will deposit full value of coal in advance for the sourcwise allocated quantity through RTGS, in favour of Western Coalfields Limited with SBI, Kingsway Branch, Nagpur (IFSC Code SBIN 0000432 A/c. No. 30413308683).
- The payment of coal value shall be accepted in 3 installments on 10 days cyclic basis in line with the provision of CSA. However, the 1st installment shall be required to be deposited by PUs within 7 days from the receipt of allotment letter. All Statutory charges, levies, taxes, royalty and other charges will also be payable, in addition to the basic price for GCV 4600-4900 i.e. G-9 Band.
- The above quantities are offered on "as is where is basis" with the stipulations that **POWER UTILITIES** would make its own lifting arrangement by Road.
- The quantities allotted must be lifted within one month from the date of issue of loading programme by the Area. In case the **POWER UTILITIES** fails to lift the allocated quantity, within the stipulated time of one month, the unlifted quantity will be considered as per the provisions of the CSA.
- The quantity booked and lifted under the allotment letter would form an integral part of the total delivered quantity for determining the level of delivery under the Coal Supply Agreement dt.12.11.2009 at the end of Financial Year 2014-15 and WCL will be entitled for incentive accordingly.
- Sampling and quality assurance will be as per the applicable clauses in the CSA dt.12.11.2009.
- In case of any revision of basic price of coal, other charges, levies and taxes etc during the validity period of the allotment letter, **POWER UTILITIES** shall arrange to immediately deposit payment towards differential amount. In case of non-receipt of differential amount, the quantity allotted shall be appropriately reduced.

You are, therefore, requested to kindly confirm the sourcwise quantities intends to book on the above Terms & Conditions within 10 days from the date of this letter, so that allotment order can be issued immediately.
