## Sub: Special Spot e-Auction held on 25.10.16 (RAIL MODE)

Vide Notice No NGP/WCL/S&M/Coordn/279 dated 26.10.16 certain modalities for booking / payment etc in respect of Special e-auction held on 25.10.16 were notified.

In continuation to the above, modalities as per special spot e-auction scheme specifically for RAIL MODE are further elaborated/ clarified as below:-

 Successful bidders & the Coal Company are to mutually decide the Monthly lifting Schedule. In this connection as Notified vide No Notice No NGP/WCL/S&M/Coordn/279 dated 26.10.16, in order to expedite scheduling, it has been intimated as below:-

In case of Supply by Rail Mode, the Sucessful Bid Quantity in rake loads will be distributed equally for the period Nov'16 to Mar'17. In the event the total quantity is not exactly divisible by five, the fractional quantity of rakes will be programmed in Nov'16 to Feb'17 as the case may be. For example, if a successful bid quantity is 11 rakes, after allocating 2 rakes for the five months period Nov'16 to Mar'17, the 11th rake will be programmed for the month of Nov'16. Similarly, in the event of successful Bid quantity being 12 rakes, after allocating 2 rakes for the 5 months period Nov'16 to Mar'17, the 11th rake will be programmed for the month of Nov'16 and 12th rake in the month of Dec'16. In case of Successful bid quantity is less than or equal to 4 rakes, the bidder can opt for any four months during Nov'16 to Mar'17 for programming one rake per month.

2. The successful bidders desiring any change in MSQ as stated above, may approach this office for jointly revising the MSQ by 29.10.16. In case of non reciept of request from the bidders for revising the MSQ or if the revised monthly schedule is not jointly agreed as requested by the bidders, the MSQ as stated in para 1 above shall be applicable

- In case of Rail despatches, rail programme shall be submitted by the successful bidder in sync with the mutually aggreeable delivery schedule, by the last day of the preceeding month.
- 4. The last such programme would be submitted on or before 7th February'16, upon which coal companies shall be issuing consents to Railways.
- Validity period for making payment to seek allotment of rake/ rakes is 45 days from the date of issuance of consent by the coal companies.
- 6. Once the rake is alloted the validity for loading is guided by the prevailing Railway rules.

The other terms and conditions of the special spot e-auction in respect of elligibility, Registration, Notification, Bidding process, post e-auction process, Refund etc will continue to be in line with Existing Spot e-auction scheme. However, in case of forfeiture in respect of lifting, the account would be reckoned at the end of 31st Mar'17.
