Sub: Inclusion of Pimpalgaon OCM of Wani North Area under Mine Specific Source Category

WCL has notified Pimpalgaon OC Mine of Wani North Area as Mine Specific Sources Vide Notice No. NGP/ WCL/ M&S/ Comml/ 297 Dated 13.08.2022, for which mine specific notified prices shall be effective wef 00:00 Hrs of 14.08.2022. Existing customers of this mine under different schemes are being offered the following one time dispensation:

- Linkage Auction: Pimpalgaon OCM being the feeding mine for Wani Siding from where NRS Linkage Auction consumers are drawing coal, the applicable price for Linkage Auction consumers will be Mine Specific Notified Price along with applicable premium discovered through Linkage Auction Mode. However such consumers may be offered One time option to Exit from the FSA/LOI (without attracting applicable forfeiture) in case of non-acceptance of Revised price by the consumers, even if the Lock-in period of 2 years of Linkage Auction FSA has not been completed. The last date for applying for exit from the FSA shall be 29.08.2022
- E-Auction: For dispatch under different auction Schemes like, Spot E-auction, Special Forward E-Auction, Exclusive E-Auction any other, all such bidders will be required to pay the winning premium over and above the revised Notified Price or they may opt for refund of coal value along with EMD. Refund of EMD will be allowed to all such consumers who opt for refund.
- Other FSA: Delivery Oder issued under any other scheme will attract revised Notified price from effective date or such consumer may opt for refund.

To continue lifting from above sources, consumers are requested to submit the differential payment at WCL HQ on or before 29.08.2022.
