Sub : Coal supply to MPLUNL under Coal Supply Agreement

WCL has released coal to M/s Madhya Pradesh Laghu Udyog Nigam Ltd (MPLUNL) against the Coal Supply Agreement (CSA) executed between WCL and MPLUNL on the strength of the nomination made by your office. As per Clause 3 of the New Coal Distribution Policy (NCDP) dated 18.10.2007 of Govt. of India, Ministry of Coal, the concerned State Govt. would be responsible to ensure that the coal allotted to the State Nominated Agency is distributed to the targetted consumers in a fair and transparent manner and to take appropriate action to prevent any misuse.

In accordance with the above, provision has been made under Clause 4 of the CSA entered between MPLUNL and WCL that MPLUNL shall submit to the State Govt. the quarterly return giving monthwise, consumerwise, unitwise details of coal sold to the targetted consumers and other relevant details of such consumers, to enable monitoring of the same by the State Govt.. To facilitate the State Govt. to ensure proper monitoring of the same, WCL has been furnishing to your office the monthly details of coal released to MPLUNL. It is expected that the necessary mechanism for ensuring distribution of coal by MPLUNL only to the targetted units in the state of Madhya Pradesh is put in place by the concerned authority of the State Govt and the compliance of the same is closely monitored from your end.


Now, we are furnishing herewith the Delivery Orderwise details of the coal released to MPLUNL for the months of Feb. 2015 and March, 2015 in the enclosed statements. The total quantity of coal released to MPLUNL for the months of Feb. 2015 and March, 2015 is as below :
