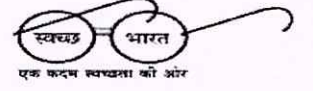

**Sub: Submission of quarterly coal utilisation certificate for coal supplied under Special Forward e-Auction and DISCOM certificate for the 4<sup>th</sup> quarter FY 2021-22.**

This is to inform all the successful bidders who have participated in Special Forward e-Auction held on 12.11.2021 & 10.02.2022, and have lifted the coal in the 4<sup>th</sup> quarter of 2021-22, that as per the clause no. 19.11 they are require to submit self-utilisation certificate along with the DISCOMs/PTC/Power Exchange/Power Traders certificate etc., within a month of the close of each quarter. The clause 19.11 states:-


Quote:

19.11 Since the coal supplied under the Special Forward e-auction is for power generation only, the Successful Bidder/Power Producer shall have to furnish a certificate after utilizing the coal supplied under the auction confirming the quantity of Power Generated from such coal at the end of every quarter. The coal supplied to each TPP under such e auction shall be informed by CIL /WCL to the concerned State DISCOMs/PTC/Power Exchange/Power Traders etc. **The Successful Bidder/Power Producer, within a month of the close of each quarter shall also furnish to WCL a certificate issued by the State DISCOMs/PTC/Power Exchange/Power Traders to IPP with a copy to CIL/Supplying Coal Company regarding power supplied to them by IPP during the quarter.**

It is to further state that the same had been certified by the successful bidders at the point no. 6 of the AFFIDAVIT CUM INDEMNITY BOND submitted by them. As such all successful bidders of the aforesaid e-auctions are required to submit the self-utilisation certificate as per the enclosed format **(Annex-I)** and the DISCOM certificate. In case of power supplied to multiple DISCOMs/PTC/Power Exchange/Power Traders etc then split up of power supplied to each DISCOMs/PTC/Power Exchange/Power Traders etc is also required to be shown.

All the successful bidders who has lifted coal in the fourth (4<sup>th</sup>) quarter of FY 2021-22 under Special forward e-Auction Scheme held on 12.11.2021 & 10.02.2022 were required to submit the necessary documents to WCL latest by 30.04.2022 but till date the same had not been submitted. As such it is once again requested to kindly submit the self-utilisation certificate and the DISCOM certificate for the coal lifted in the fourth (4<sup>th</sup>) quarter of FY 2021-22 by 14.04.2022.
