Non power Consumers drawing coal in LOA route (G9 grade) are informed that the rakes shall be allotted from Sasti/Chargaon Siding only.

Application for release of Coal against entitlement month of **Oct'16** may be submitted by **20th Oct'16**. Successful Bidders of linkage e-Auction are also advice to apply for release of Coal for the month of Oct'16 with all details like Bid Qnty, Siding, priority etc.

In case of choice of desired sidings exercised by consumers exceeds Nos of rakes offered from any one siding, allocation shall be made on prorata basis.

WCL reserves the discretion to change/allocate sidings, depending upon coal availability and operational convenience. No correspondence in this regard shall be entertained.
