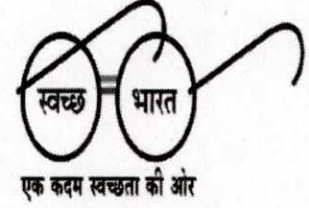

NOTICE TO THE FSA CONSUMERS FOR ALLOCATION OF COAL BY ROAD MODE FOR THE MONTH OF NOV'18

Kind Attention is invited to the consumers in the enclosed list for allocation of coal by Road Mode. The Monthly Allocation of coal to FSA consumers for the month of Nov'18 has been completed on 28.11.18. However, in the meantime we had received representation from M/s ACC Ltd., M/s Maratha Cement Ltd. and M/s J.K. Paper Ltd. (CPP) that they are eligible for higher quantity than the notified quantity as these consumers have bid their quantities under Linkage Auction in both Rail and Road mode in the CPP sub sector. Now, the entitled quantity of these consumers have been revised and the additional quantity that these consumers are eligible to apply is notified in the 'Annex-1'.

Also, we had discontinued coal supplies to the following consumers from Nov'18 onwards due to non participation in NRS Auction of coal Linkages for CPP sub sector which concluded in the month of Oct'18.

2. M/s Vardhman Acrylics Limited
3. M/s Indo Rama Synthetics (I) Limited
4. M/s Indo Afrique Paper Mills (P) Limited
5. M/s The Sanjivani (T) Sahakari Karkhana Ltd.
6. M/s Shree Rama Newsprint Ltd.,

M/s Raymond UCO Denim Private Limited, M/s Vardhman Acrylics Limited, M/s Indo Rama Synthetics (I) Limited, and M/s Indo Afrique Paper Mills (P) Limited had made a request to this office stating that their CPP is Cogen CPP and are participating in the 'Others' sub sector as per the Notice of CIL dt. 12.10.18, and requested for release of coal for the month of Nov'18 and Dec'18 also as the Auction for the 'Others' sub sector in this Tranche gets completed in the month of Dec'18.

On scrutiny of old documents and SLC (LT) minutes it has come to the notice that M/s Raymond UCO Denim Pvt. Ltd. was allocated coal for its CoGen CPP in the SLC (LT) meeting held on 06.11.2007 which is appearing in our records currently as CPP. Hence, coal supply shall be considered for Nov'18 and Dec'18 also.

WCL had executed two FSAs for CPP and Process separately with M/s Indo Afrique Paper Mills (P) Limited as per the extant guidelines circulated by CIL for Co Gen CPP. Accordingly, for CPP, FSA had been executed on the basis of normative quantity declared by CIL and the process quantity has been considered as 75% of balance quantity of long term linked quantity. Hence, coal supply shall be considered for Nov'18 and Dec'18 also.

The documents submitted by M/s Indo Rama Synthetics (I) Limited and M/s Vardhman Acrylics Limited are still under scrutiny and as such these consumers are again requested to submit the documents issued by CIL/MoC stating that their unit is CoGen CPP. Nevertheless, allocation to these two units against the MSQ for the month of Nov'18 has been considered provisionally. However, release of coal shall be subject to satisfactory clearance of the documents submitted by the consumers.

It should be ensured that the total quantity applied for does not exceed the applicable Entitled Quantity indicated in Annexure-1. In case the total applied quantity exceeds the Entitled Quantity, the quantity applied in excess of the Entitled Quantity shall be deducted from the source from which maximum quantity is applied for. Similarly, the quantity applied from a source should not be more than the quantity offered from the source.

In case the total applied quantity from a source is less than the offered quantity, the entire applied quantity shall be allocated to the consumer. In case the total applied quantity is more than the offered quantity from a source, the allocation shall be prorated on the basis of the quantity applied by each consumer. Consumers are required to indicate the preference of source of allocation for the balance quantity and balance quantity shall be allocated from that source.

The applications are to be submitted at Road Sales Section, M&S Dept., WCL Hqr on or before 12:00 pm of 07.12.2018. The consumer-wise, source-wise quantity of coal allocated against the applications as per the procedure stated in this Notice and the balance quantity pending for allocation against the SQ shall be displayed in our website on 07.12.2018 itself.

The last date for submission of payment against the allocations for the month of Nov'18 shall be 15.12.18.
