### NOTICE TO THE CSA CONSUMERS FOR ALLOCATION OF COAL BY ROAD

Applications from CSA consumers (other than Power Utilities and IPPs) are invited for allocation of coal by road for the month of Aug'16 as per the procedure given below.

1. The source-wise, size / grade-wise quantity of coal available for allocation by road mode for Aug'16 is displayed herewith as **Annexure-1**.
2. The consumers are categorised into 10 Groups for the current month based on their entitled size/grade of coal for release, location of the mines, location of the consumers and availability of coal. The groups and the collieries and the size/ grade of coal for which consumers in each group are entitled for release of coal is displayed herewith as **Annexure-2**.
3. The consumers shall be required to make application and indicate the source-wise, grade-wise quantity of coal desired for allocation in the below mentioned format:

It should be ensured that the total quantity applied for does not exceed the Monthly Scheduled Quantity (SQ) applicable under the CSA for the month of Aug'16. In case the total applied quantity exceed the SQ, the quantity applied in excess of the SQ shall be deducted from the source from which maximum quantity is applied for. Similarly, the quantity applied from a source should not be more than the quantity offered from the source as per Annexure-1.

4. It should be ensured that application for allocation is made only from the source(s) mapped for the concerned group and the application from the source(s) which is not mapped for the consumer shall be rejected.

5. The applications are to be submitted at Road Sales Section, S&M Dept., WCL Hqr on or before 17.08.2016 (Forenoon). The consumers can also send their applications through facsimile to Telephone No. 0712-2512977 and also by mail to ID: wclrdsales@gmail.com. The applications received beyond 17.08.2016 shall not be considered for allocation of coal in the 1<sup>st</sup> round.

6. In case the total applied quantity from a source is less than the offered quantity as displayed in Annexure-1, the entire applied quantity shall be allocated to the consumer. In case the total applied quantity is more than the offered quantity from a source, the allocation shall be prorated on the basis of the quantity applied by each consumer, subject to the other criteria mentioned herein.

7. The small consumers whose SQ is upto 350 tonnes shall be allocated 100% of the applied quantities, provided the total applied quantity from the source(s) by such small consumers is within the offered quantity from the concerned source(s).

8. SQ of M/s MOIL Ltd., for its plants at Balaghat and Tumsar is pre-allocated from Sasti UG (Mix G6G6) and Makardhokra I OC (Mix G7G8) respectively. SQ in respect of 6 no. of coke ovens entitled for WG-II Grade coal is pre-allocated from Tandsi Mine. The consumer-wise details of the quantity pre-allocated for which these consumers are required to make payment are displayed herewith as **Annexure -3**.

9. M/s Birla Cellulosic, which is paying 140% of the notified basic price towards purchase of coal shall have priority in allocation of coal from the sources mapped for it over the other consumers (except small consumers).

10. Industrial consumers of MP shall have priority in allocation of coal from the sources of MP over the State Nominated Agencies.

11. The consumer-wise, source-wise quantity of coal allocated against the applications as per the procedure stated in this Notice and the balance quantity pending for allocation against the SQ shall be displayed in our website on 18.08.2016. The consumers shall be required to submit fresh application for 2<sup>nd</sup> round of allocation towards such unallocated quantity on or before 19.08.2016 as per format indicated in Para 3 above.

12. The source-wise quantity allocated to the consumers against the 2<sup>nd</sup> round of allocation as per the procedure stated in this Notice shall be displayed in our website on 19.08.2016 itself. The date for submission of applications towards unallocated quantities if any, after the second round of allocation shall be 20.08.2016 and the details of allocation shall be displayed in our website on 20.08.2016 itself.

13. The last date for submission of payment against the allocations for the month of Aug'16 shall be 30.08.2016. However, payment shall be accepted only by way of EFT/RTGS.

14. Release of coal against the allocation as per the above procedure shall be subject to conditions informed to the consumers vide notice No.NGP/WCL/S&M/C-12(348)/824 dated 12.8.2016, validity of the CSAs and verification of the monthly documents in case of the erstwhile non core sector consumers.

15. The CSA holders through LoA route are advised to make application against the quantities notified for allocation under this notice only towards the domestic component of coal agreed under the under the CSAs.
