This is in reference to notice no NGP/ WCL/ M&S/ 109 dt 01.07.2021 (copy enclosed at annex - I) regarding revision of Surface Transportation Charges (STC) from pit-head to loading point of coal for all existing lead distance wef 00:00 hrs of 25.06.2021, wherein, it was notified that the existing STC for 10-20 km slab will be revised and communicated later.

It is to notify all the consumers/ bidders of WCL that the STC for 10 - 20 km lead distance wef 00:00 hrs of 25.06.2021 remains Rs 115 per tonne till further revision. The STC for different distance slabs are as follows:
