With reference to above you had submitted the tender, which were opened on 08.07.2019. While scrutinizing your tender documents, deficiencies were observed as under:

1. That, you had not uploaded the following documents while submitting the tender, which were the part of qualifying criteria as per NIT..
 - (a) Work order
 - (b) Bill of quantity
 - (c) Completion certificate
 - (d) TDS & statement of bills
2. Online clarification was sought from you for uploading the above mentioned documents between 11.07.2019 to 18.07.2019.
3. In reference to our clarification you uploaded the documents on 15.07.2019
4. Your uploaded documents dtd 15.07.2019 were sent to following concerned Agencies/Departments for confirmation of authenticity on 26.08.2019
 - (a) M/S Refrathern International Pvt Ltd. Nagpur
 - (b) M.D. Rajput & Co, Chartered Accountant, Nagpur
 - (c) Branch Manger, Central Bank of India, Nagpur
 - (d) Branch Manger, Bank of India, Nagpur
5. No reply was received from M/S M.D. Rajput & Co. Other three agency/department replied to our letter but that was not conclusive..
6. On dtd 16.09.2019 a letter was received from you vide Ref: DE/59 dtd 10.09.2019 indicating as " **Due to Medical problem in family not ready to work.**" which amounted to withdrawal of your bid.

7. Confirmation was sought from you, vide this office letter No. WCL/GSD/2019-20/272 dtd 20.09.2019, regarding your request letter dtd 10.09.2019 for withdrawal of tender bid and in response you had confirmed the withdrawal of your bid vide letter No DE/60 dtd 22.09.2019 received in this office on 27.09.2019.

As per clause No.4.10 of Tender Notice, withdrawal of bid may be allowed till the issue of work order/LOA with the following provision of penal action :

- (i) The EMD will be forfeited
- (ii) The bidder will be debarred for 1(one) year from participating in tenders in CIL/Subsidiery.

In view of above the above, your request for withdrawal of bid has been approved by the competent authority with the condition that your EMD will be forfeited and you will be debarred for 1(one) year from participating in tenders in CIL/Subsidiery.

Therefore you are hereby informed that your EMD amounting to Rs 77900/- (Rs seventy seven thousands nine hundred only) is forfeited and you are debarred for 01 (one) year from participating in tenders in CIL/Subsidiary from the date of issue of this letter.
