### NOTICE TO ALL CONSUMERS DRAWING COAL UNDER FSA

CIL in its 237<sup>th</sup> meeting of CFDs held on 15.08.2020 has accorded approval for waiver of Performance related obligation during the pandemic period evoking the force majeure provisions of the respective FSAs as a dispensation.

In terms of the approval, the following dispensation(s) have been allowed:

1. The FSA consumers (Both Power and non-power FSAs) are given an option to apply for invoking FM relief under the FSA for the period Apr-May 2020 as a one-time dispensation.
2. The timeline for claiming FM relief as per FSA (Both Power and non-power FSAs) by the Affected Party are waived of in view of Pandemic situation prevailing in the country. Accordingly, all the willing FSA consumers may apply for availing FM relief citing the reason of epidemic (COVID 19) for non-performance during the lockdown period, viz. April & May 2020 on or before 06.10.2020. It is to be noted that the relief shall be to the extent of prorated MSQ of April & May 2020.
3. Willing FSA consumers would also request for waiver of the FSA condition for adhering stipulated timeline and also their obligation to present Burden of Proof. WCL on receipt of such application may extend the applicable relief under FM.
4. In the event of receipt of relief under FM, WCL is also required to declare FM for the same period and shall follow the similar procedure.
5. Facility to rebook the unbooked/unlifted quantity of any month in the subsequent months within current FY upto the ceiling of ACQ by the non-power FSA consumers shall be as per the our Notice no. NGP/WCL/M&S/Comm/224 dt. 07.07.2020. In the event, the consumer is able to lift the scheduled quantity for April and May during rest of the year in terms of the dispensation, the application for invoking FM shall be treated as cancelled for that quantity.

All willing FSA consumers availing FM relief citing the reason of epidemic (COVID 19) for non-performance during the lockdown period, viz. April & May 2020 are advised to submit the application on or before 06.10.2020.
