## Price applicable for supplies to the Power Plants not having FSA with WCL under Flexi-Utilisation Policy

Committee of Functional Directors (CFDs) of CIL in its 295th meeting held on 22.11.2022 approved the following for supplies made under Flexi-Utilisation Policy -`Charging of 40% premium over and above basic ROM notified price for both Type A (Plants having no FSA with respective subsidiary of CIL) and Type B (Plants having no FSA with any of the Subsidiary of CIL) power plants for supply of coal under flexi utilisation policy'

Further, CFDs approved that the revised pricing shall be made applicable from the date of decision of CFDs i.e. w.e.f. 22.11.2022.

In view of above, all the plants which are procuring coal from WCL under Flexi-Utilisation Policy, but not having FSA for coal supplies from WCL in respect of the concerned plant shall be charged premium as mentioned hereunder:-

a) 40% flat premium over and above notified price / mine specific notified price across all grades shall be charged for supply of coal under Flexiutilisation Policy.

b) The premium shall be applicable w.e.f. 22.11.2022.

c) Debit Notes for differential amount shall be raised in case of despatches already made to such power plants under Flexi-Utilization Policy on or after 22.11.2022.
