NOTICE TO THE CSA CONSUMERS FOR ALLOCATION OF COAL BY ROAD FOR THE MONTH OF JAN'20

Applications from CSA consumers (other than Power Utilities, IPPs and FSAs holders under Linkage Auction route) are invited for allocation of coal by road for the month of Jan'20 as per the procedure given below.

1. The source-wise, size/grade-wise quantity of coal available for allocation by road mode for Jan'20 is displayed herewith as **Annexure-1**.
2. The consumers are categorized into 5 Groups for the current month based on their entitled size/grade of coal for release, location of the mines, location of the consumers and availability of coal. The groups and the collieries and the size/ grade of coal for which consumers in each group are entitled for release of coal are displayed herewith as **Annexure-2**.
3. The consumers shall be required to make application and indicate the source-wise, grade-wise quantity of coal desired for allocation in the below mentioned format:

It should be ensured that the total quantity applied for does not exceed the applicable Entitled Quantity indicated in Annexure-2. In case the total applied quantity exceeds the Entitled Quantity, the quantity applied in excess of the Entitled Quantity shall be deducted from the source from which maximum quantity is applied for. Similarly, the quantity applied from a source should not be more than the quantity offered from the source as per Annexure-1.

4. It should be ensured that application for allocation is made only from the source(s) mapped for the concerned group and the application from the source(s) which is not mapped for the consumer shall be rejected.

5. The applications are to be submitted at Road Sales Section, M&S Dept., WCL Hqr on or before **12:00 PM of 05.02.2020**. The consumers can also send their applications through facsimile to Telephone No. 0712-2512977 and also by mail to ID: wclrdsales@gmail.com. The applications received after **12:00 PM of 05.02.2020** shall not be considered for allocation of coal in the 1st round.

6. In case the total applied quantity from a source is less than the offered quantity as displayed in Annexure-1, the entire applied quantity shall be allocated to the consumer. In case the total applied quantity is more than the offered quantity from a source, the allocation shall be prorated on the basis of the quantity applied by each consumer, subject to the other criteria mentioned herein.

7. The small consumers whose SQ is upto 350 tonnes shall be allocated 100% of the applied quantity from a source, provided the total applied quantity from that source by all such small consumers is within the offered quantity from the concerned source.
8. SQ of M/s MOIL Ltd., for its plants at Balaghat and Tumsar is pre-allocated from Sasti UG (Mix G7G8) and Umrer OC (G8G9 Mix) respectively. Similarly, the SQ of Maharashtra Agro Industries Development Corporation Limited is pre-allocated from Umrer OC (G8G9 Mix) OC.
9. Priority to consumers namely, M/s Bilt Graphic Paper Products Ltd & M/s UltraTech Cement Ltd through LOA route are being given for allocation from Cr. ROM (-100mm) sources.
10. The consumer-wise, source-wise quantity of coal allocated against the applications as per the procedure stated in this Notice and the balance quantity pending for allocation against the SQ shall be displayed in our website on **05.02.2020** itself. The consumers shall be required to submit fresh application for 2nd round of allocation towards such unallocated quantity before **12:00 PM of 06.02.2020** as per format indicated in Point No. 3 above.
11. The consumer-wise, source-wise quantity allocated to the consumers against the 2nd round of allocation as per the procedure stated in this Notice and the balance quantity pending for allocation against the SQ shall be displayed in our website on **06.02.2020** itself. The date for submission of applications towards unallocated quantities if any, after the 2nd round of allocation shall be on or before **12:00 PM of 07.02.2020** and the details of allocation shall be displayed in our website on **07.02.2020** itself.
12. The last date for submission of payment against the allocations for the month of Jan'20 shall be **17.02.2020**. The consumers are urged to make payments only through RTGS/NEFT. The consumers are urged to make payments only through RTGS/NEFT.
