Sub: Coal supply to NSBIA under Coal Supply Agreement

WCL has released coal to M/s New Saurashtra Briquetting Industries Association (NSBIA) against the Coal Supply Agreement (CSA) executed between WCL and NSBIA on the strength of the nomination made by your office. As per Clause 3 of the New Coal Distribution Policy (NCDP) dated 18.10.2007 of Govt. of India, Ministry of Coal, the concerned State Govt. would be responsible to ensure that the coal allotted to the State Nominated Agency is distributed to the targetted consumers in a fair and transparent manner and to take appropriate action to prevent any misuse.

In accordance with the above, provision has been made under Clause 4 of the CSA entered between NSBIA and WCL that NSBIA shall submit to the State Govt. the quarterly return giving monthwise, consumerwise, unitwise details of coal sold to the targetted consumers and other relevant details of such consumers, to enable monitoring of the same by the State Govt.. It is expected that the necessary mechanism for ensuring distribution of coal by NSBIA. only to the targetted units in the state of Gujarat is put in place by the concerned authority of the State Govt and the compliance of the same is closely monitored from your end.

The total quantity of coal released to NSBIA for the months of May, 15 to Sept. '15 is as below:

The Delivery Orderwise details of the coal released to NSBIA for the months of May'15 to Sept'15 are given in the enclosed statement along with the Notified & Gross per tonnes price of coal. The Delivery Orderwise, truckwise lifting details are being sent by our Area offices on monthly basis to your office to help you monitor the distribution of the same to the targetted consumers.

In view of the above, we once again request you to ensure that coal released to NSBIA is distributed to the targetted consumers for genuine consumption in strict compliance of the provisions of NCDP and CSA and the coal is not misused in any manner.
