**Sub: Modification in Model FSA applicable for State Nominated Agencies**

Dear Sir,

The following modifications in Model FSA applicable for State Nominated Agencies has been approved in 317<sup>th</sup> CIL Board meeting held on 13<sup>th</sup> July'15.

- The tenure of FSA shall be 2 years or less corresponding to the period for which the nomination would be received from the nominating State Government.
- The restriction of limiting supply on quarterly basis was removed to allow carry-over of value paid orders till the end of the contract.
- The restriction of carry over in case of inability to lift coal by the purchaser for whatsoever reason to subsequent months had been removed for value paid orders even for quantities which could not be lifted by the purchaser within 45 days.
- The quantity considered as deemed delivery on account of Railway Failure(RF) has been removed and
- The scope for termination of FSA on account of less than 30% lifting has also been removed against forfeiture of SD.

As in most of cases the nomination from State Govt. has been received for one year hence as per existing practice point 'a' is to be implemented from the year 2016-17.

Accordingly the clause wise modification in comparison to existing clauses of Model FSA applicable for State Nominated Agencies which has been legally vetted is enclosed as Annexure -A. (Pgs. 1 to 7)

A format has evolved in line with clause 4.4 of the FSA through which the state agency should submit a quarterly return for evaluation of genuine consumption and monitoring of the same by the State Government and shall be hoisted in the website of the State Nominating Authority/Agency for public viewing is enclosed as Schedule VI of FSA.
