As per the Grade Declared for the year 2017-18, Coal Produced from Tandsi Mine is graded as Washery Grade –IV. As there was no Price Notification for declared grade WG-IV for WCL in CIL's Price Notification dated 26.2.2011 it has been decided to fix the prices of WG-IV Raw Coking Coal being produced in the mines of Tandsi, WCL w.e.f 00 Hrs of 1.4.2017 as below. Though the present Grade of coal at Tandsi UG Mine is WG-IV, but Prices of WG-III are also being notified for any variation in future.

Following Clauses of Price Notifications, issued by CIL from time to time are also proposed for approval for incorporating it for implementation.

- Additional Rs 20.0 / Te shall be charged on pit head price of ROM Coal for supply of slack coal
- Additional Rs 180.00 per tonne shall be charged on pit head price of ROM coal for the supply of Steam coal
- Where the top size is being limited to any maximum limit within the range of 200mm 250 mm through manual facilities or mechanical means, a charge of Rs 51.00 per tonne will be levied in addition to the price applicable for ROM coal.
- Where the top size is being limited to 100 mm through manual facilities or mechanical means, a charge of Rs 79.00 per tonne will be levied in addition to the price applicable for ROM coal.
- 5. Where the top size is being limited 50 mm through manual facilities or mechanical means, a charge of Rs 100.00 per tonne will be levied in addition to the price applicable for ROM coal.
- 6. Where coal is loaded either into Indian Raiways system or into Purchaser's own system of transport, through high capacity loading system with a nominal capacity of 3500 tonnes per hour or more, additional charge of Rs 28.00 per tonne shall be levied for such loading.
- 7. Where coal is transported beyond a distance of 3 Kms to the loading point, the coal companies will be entitled to charge additional transport costs from the Purchaser at the following rates:
 - a) For a distance of more than 3 KMs but not more than 10Kms, Rs 57.00 per tonne.
 - b) For a distance of more than 10 KMs but not more than 20Kms, Rs 116.00 per tonne.
 - c) In cases, where coal is transported for more than 20 Kms to the loading point, transport charges will be payable on actual basis, to be borne by the Purchaser.
- 8. The Pit head prices fixed are exclusive of Royalty, cess, taxes and levies, if any, levied by the Government, Local Authorities or any other bodies of Excise & Sales Tax from time to time.
- 9. Grading/ Classification of coal and the definitions relating to the same(or amended by the Competent Authoritytime to time) have been given in Annexure-X of CIL Price Notification No CIL:S&M:GM(F):Pricing:1907 dated 26.2.2011.
- 10. The above proposal prices are either FOR or FOB, as the case may be. Surface Transportation charges where applicable, would be levied extra.
- 11. The prices do not apply to coal sold for export.
- 12. For under taking special sizing or beneficiation of coal, additional charges as may be, negotiated between, the Purchaser and the Producer may be realized over and above the pit head prices. However, in case of Selective Loading, wherever

applicable, which is not covered under the purview of special sizing or beneficiation, the prices shall be governed by clause 12(b) as below:-

- 12(b)(i) All Selective loading irrespective of means of loading and modes of dispatch to be considered as loading of steam sized coal of +25mm. Therefore in case of selective loading, wherever applicable, steam sizing charge, which is presently Rs 180 Per tonne be charged on the ROM Price on account of Sizing.
- (ii) In addition to 12(b)(i) above, beneficiation charges to be levied for all selective loading. The beneficiation charge be the price difference as per the grades identified in the grade notification of the coal company for Steam & ROM respectively.
- (iii) Thus the Selective loading charge from the ROM be the summation of the steam sizing charge ie Rs 180.00 per tonne and difference of price arising out of grades of steam and ROM.
- Orininal Clause No 13 & Clause No 14 of CIL Price Notification No CIL:S&M:GM(F):Pricing:1907 dated 26.2.2011 are not applicable henceforth.
- 14. Any other charges as are being levied by WCL over and above those being notified by / WCL/CIL shall continue to be levied.
