विषय: Extension of Validity period of Delivery Orders by Road mode in view of lock down due to Pandemic COVID-19.

All consumers who are lifting coal by road mode are hereby informed that validity period of Delivery orders are extended in view of the outbreak of Novel Corona Virus in the country with subsequent enforcement of State level lockdown w.e.f 00:00 Hrs 21.03.2020 and country level lockdown for a period of 21 days in the country w.e.f. 00:00 hours of 25.03.2020 (i.e upto 14.04.2020).

CIL vide letter no CIL/DM(Secy)/1802 dated 28.03.2020 has given dispensation regarding extension of the period of lifting of coal through road mode. Accordingly, it has been decided that the validity of Delivery Orders shall be extended beyond the lock down period by number of days for which the lifting impacted due to lock down w.e.f 21.03.2020 plus 2 (two) days as buffer time. The total number of days given for lifting against any Delivery order should be given 45 days and 2 (two) days as buffer time excluding the lock down period. The calculation to decide the validity extension is clarified through sample illustration given below:
