**NOTICE FOR THE CONSUMERS EXECUTED FSA UNDER LINKAGE AUCTION ROUTE
FOR SUPPLY OF COAL BY ROAD MODE**

The consumers who have executed Fuel Supply Agreement (FSA) for supply of coal secured under linkage auction with option for availing third party sampling are hereby informed that pending decision regarding choice of the third party agency to conduct the sampling in accordance with Schedule-VII of the FSA, they can avail supply of coal under the FSA by opting either for Joint Sampling or without sampling. The consumers opting for Joint Sampling of coal till commencement of Third Party Sampling arrangement are hereby requested to approach the office of General Manager(QC), WCL for arriving at the jointly agreed procedure. In case of consumers opting for supplies without sampling, the supplies shall be made on contracted grade basis and the As Delivered Price of the contracted grade shall be applicable for such supplies for all commercial purposes under the FSA.

The last date for making the requisite advance payment for issue of Delivery Orders against the Scheduled Quantity (SQ) for the month of October, 2016 shall be 10.11.2016.

The last date for making advance payment for issue of Delivery Orders against the Scheduled Quantity (SQ) for the month of November, 2016 shall be 25.11.2016. In case of consumers seeking to make advance payment for the SQ of November, 2016 in three equal installments as per Clause No.8.2.2 of the FSA, the first installment of advance towards 10 days coal value be made by 10.11.2016, the second installment by 15.11.2016 and the third installment by 25.11.2016.

The last date for making advance payment for issue of Delivery Orders against the Scheduled Quantity (SQ) for the month of December, 2016 onward shall be 21st day of the respective month. In case of consumers seeking to make advance payment for the SQ in three equal installments as per Clause No.8.2.2 of the FSA, the first installment of advance towards 10 days coal value be made by 1st day of the month, the second installment by 11th day of the month and the third installment by 21st of the month. In case of the due date falling on a holiday for the office of WCL, Hqr, the payment should be made on the next working day.
