Sub: Revision of Surface Transportation charge from pit-head to loading point of coal for all existing lead distance w.e.f. 00:00 Hrs of 29.06.2018

This is for information of all the consumers/ bidders of WCL that the Surface Transportation Charges from pithead to loading point of coal from existing lead distances will be effective from 00:00 Hrs of 29.06.2018 and will be as under:

Distance Slab (Km)	Rate (Rs/Te)
0 to 3	25
3 to 10	65
10 to 20	100
Above 20	Actual STC + 10% i.e 110% of Actual STC

Till such time the differential amount is not paid by the customers / bidders the Areas shall withold the delivery of the balance quantities against the respective delivery orders in proportion to the amount recoverable due to this revision.

The differential amount on account of increase in the price should be directly submitted at the areas for the running Dos. For the Dos pending to be issued, the customers/ bidders may deposit the differential payment on or before 10.07.2018.
