Sub: Revised Offer of coal from Temporary Source by Road Mode for the month of May'2018 under Change of Mode of Supply to Linkage Auction for Non Regulated Sectors

Vide our Notice No. NGP/WCL/M&S/2018/507 Dated 07.06.2018, allocation of Temporary Source in Road Mode was intimated to eligible Linkage Auction Consumers for supply of coal on change of Mode from Rail to Road.

Against Primary Siding of Wani Siding & Ghugus Old Siding, Mungoli OC (G13) was allocated as Temporary Source by Road Mode. Due to constraint of Road Despatches at Mungoli OC, allocation made from Mungoli OC mine against the rakes / rail quantity (MSQ) of Ghugus old Siding as well as Wani Siding is cancelled and in lieu of same, allocation from Penganga OC (G10 -100mm) is considered for change of mode in respect of Rakes / Rail Quantity (MSQ) as the Temporary Source in Road Mode from Ghugus Old Siding.

Since no option of Temporary Source against rakes / Rail despatches from Wani Siding could be made available as per the modalities of change of source, no allocation of temporary source against Wani Siding is being made. Therefore, the coal supply against Wani Siding shall be made by Rail Mode only.

The price payable for supply of coal through Penganga G10 (-100mm) would be Rs. 1719.31/- per tonne (including commitment charge). The 'As delivered price' per tonne will be Rs. 2708.99/-.

Consumers who have already deposited coal value as per the earlier notice are advised to deposit the balance coal value due to change of temporary source from Mungoli (G13) to Penganga (G10) on or before 17.07.2018 in respect of Rake / Rail Quantity (MSQ) for May'18 against Ghugus Old Siding.

Consumers who have deposited coal value against MSQ for May'18 from Wani Siding are requested to apply for refund.
