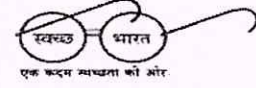



WCL has notified Ghonsa OC Mine of Wani North Area as Mine Specific Sources Vide Notice No. NGP/WCL/GM(M&S)/2022/ 190 Dated 20.06.2022, for which mine specific notified prices shall be effective wef 00:00 Hrs of 21.06.2022. Existing customers of this mine under different schemes are being offered the following one time dispensation:-

- Linkage Auction:** The Linkage Auction consumers having FSA for supply of coal from Wani Siding as primary source shall required to pay the revised notified price along with percentage of winning premium on revised price, as Ghonsa OCM is feeding mine to Wani Siding.
